APPLICANT SHALL SUBMIT:

- PERMIT APPLICATION FORM,
- A MINIMUM OF THREE (3) COMPLETE SETS OF DRAWINGS,
- MANUFACTURERS OR ENGINEERING SPECIFICATIONS,
- PHOTOSTATIC COPY OF RME, APS, SCR, ACR, OR OTHER APPLICABLE CERTIFICATION FROM THE TEXAS DEPARTMENT OF INSURANCE – STATE FIRE MARSHAL’S OFFICE.

SUBMITTALS SHALL COMPLY WITH THE REQUIREMENTS OF ANY APPLICABLE NFPA STANDARDS.

ONE SET WILL BE RETAINED BY THE FIRE MARSHAL’S OFFICE, TOWN OF PONDER, TEXAS.

This submittal will be reviewed for compliance with the 2003 International Fire Code and North Central Texas Council of Governments Amendments to the Fire Code. The applicant is responsible for compliance with all applicable portions of the Fire Code, Amendments and Ordinances even in the absence of review comments. (Town of Ponder, Texas - Ordinance No. 04-24)

(1) When an application for a demolition permit is filed with the Planning and Zoning Director for consideration and approval it shall be accompanied with a demolition permit deposit of \$100 and a demolition permit fee of \$10. The permit deposit will be refunded after final inspection approval from the Building Inspector.

(2) A re-inspection fee of \$47 will be assessed if a second re-inspection is required by the Building Inspector.

(K) *Contractor registration fee.* An annual contractor fee of \$25 per year to be renewed annually. (Ord. 03-17, passed 3-10-2003; Am. Ord. 06-25, passed 10-10-2006)

(L) *On-site sewage facility inspection fee.*

(1) On-site sewage facility inspection fee: \$260.

(2) On-site sewage facility administrative fee: \$240.

(3) Total fee for on-site sewage facility permit: \$500.

(M) *Fire permit fees.*

(1) Construction plans (Fire Code compliance): \$45 per hour, two hour minimum.

(2) The following fees include plan review and one acceptance inspection:

(a) Fire sprinkler system - aboveground: \$235. Each system riser or system as defined by size according to NFPA 13 shall constitute a separate system requiring a separate permit. (3 risers = 3 permits).

(b) Fire sprinkler system - underground: \$185.

(c) Fire alarm system: \$335.

(d) Alternative fixed fire suppression systems (non-sprinkler system): \$235.

(e) Other fire code permits: \$235.

(f) Witness annual fire protection system inspection: \$45 per hour, two hour minimum.

(g) Construction and miscellaneous fire inspections: \$45 per hour, two hour minimum.

(h) Reinspection fee: \$45 per hour, two hour minimum.
